Fees Explained...

Enrolling into KLDA:

- KLDA charge monthly tuition fees.
- Our fees are split over 39 weeks of the academic year August - July into 12 months of affordable payments. All fees are inclusive of VAT (where applicable) & bank transaction charges.
- Our monthly payments cover 3.25 weeks in advance.
- All new students enrolling into classes will need to pay a joining fee. This includes a KLDA tote bag + goodies. The fee will also include the tuition calculated pro-rata.
- The joining fee will take you up to the next monthly tuition payment.
- From this payment, you will then be charged on our pro-rata monthly payments.
- Our terms operate similarly to school. We break for half terms, Christmas, Easter & the Summer (during these periods we offer camps, workshops or classes charged separately).
- The joining fee will be placed onto your account, which needs to be paid prior to the start date to continue to attend classes.

Monthly Tuition:

- Our tuition is based on a 12 monthly system.
- 39 weeks academic year is split into 12 monthly affordable payments.
- Fees for current students will start on the 1st August & run through to 1st July.
- All monthly fees are due on the 1st of every month.
- Our classes do not accept pay as you go.

An option to set up AUTO PAY is available. (We recommend this option)

AUTOPAY: KLDA will bill your account 3-5 working days prior to the 1st of the month. (This is because it takes this length to clear the payment).

Please note; this payment is monthly recurring.

Please note; if your autopay payment fails, this may be due you needing to update your card details (you can do this via the app) or not enough funds in your account. If the payment fails you will need to pay the bill manually. Please contact info@kristielouisedanceacademy.co.uk to discuss further if required.

If the matter is not amended straight away, you will be charged a 15% late fee after the 1st of the month.

If you do not set up AUTO PAY you will need to pay by Manual Pay.

Manual Pay is controlled by you. You must remember to pay your fee on the 1st of every month.

Please note; by using Manual Pay, you are at risk of a 15% late fee charge.

Fees Explained...

Trial Classes:

- All students are welcome to trial a class in each genre.
- There is a trial charge per class.
- This payment needs to be paid in advance & cannot be refunded once paid. If you cannot attend your original trial date, KLDA will be happy to move this date once (as long as the class list is not full).
- You are welcome to trial more than one class, but each class will need to be paid for.
- Once a trial class has been attended, you will be asked if you would like to accept a permanent space at Kristie Louise Dance Academy (KLDA). If you do not accept the space straight away & there is a waiting list, it will be offered to the next person.
- If you &/or your child are not 100% sure there is an option to attend another paid trial class or a paid trial month before enrolling.

Singing Lessons/Private Lessons/Competition Team:

- All singing, private lessons & competition team fees are charged separately.
- An invoice will be sent via Xero & they are required to be paid via Bank Transfer.
